Explanation of significant increases in the budget:

Multi-year continual decline in valuation has resulted in significant lost operational revenues over the past 3 years. Significant increases in city liability & property insurance expected in 2024 require the use of the liability & property insurance levy. Employee benefit expenses set to increase 8%, with increase in ambulance department benefit levy of 50% due to ambulance revenues deficit. Addition of liability & property insurance levy to be offset by discontinuation of current debt service levy in FY24.
