




Scope of Work

- Reconstruction of 7th Avenue:
 - Match existing varying road width
 - Back-of-curb to back-of-curb 34-45ft
 - New curb and gutter
 - Sidewalk to remain in place
 - Replacing all driveways along project route up to the front of sidewalk
 - Replace all existing water main as well as water services from the water main to the right-of-way (ROW), including curb stop & box
 - 2,200 LF of water main replacement
 - Install new storm sewer structures and piping
 - Signs honoring the historical significance of original Lincoln Highway

So many water main breaks, so many repairs! *Original water is 4-inch cast iron installed in 1926!










Typical Cross Section

Detour Route






Easements

- No Permanent Easements Anticipated
- Temporary Easements
 - Some properties may require temporary easements. These are in-place only for the duration of construction and typically are needed for tying pavement into existing pavement or grading yards with suitable slopes and restoring driveways

Tree/Landscaping Removal Will my landscaping be disturbed?

Answer -

 Landscaping within 4-ft of the back of curb will likely be disturbed by construction. The City has already removed trees anticipated to be impacted by construction.





Water/Sewer Service Installation

Will I be required to install a new water and/or sewer service line?

Answer -

- Water services from the main to the curb stop will be installed as part of this project. Residents have the option to replace the remainder of their water service line between the roadway right-ofway (ROW) and their homes, at their own expense.
- This cost of replacement from (ROW) to house may be negotiated with the contractor (if the contractor is willing) or a private plumber.
- Residents affected with lead service lines should let the City know; the Contractor will also be looking to see if the service from the curb stop to the house is lead as well to try and locate and lead services. Lead service replacement from the curb stop to the house will be the responsibility of the resident.



Access during Construction

Will I have vehicle access to my home at all times, and if not, how long will I be without access and where should I park?

Answer –


- Most residents will lose vehicle access to their driveway at various times during the construction process. The most common times being during roadway core out, paving, and driveway placement.
- During core out, vehicle access is typically unavailable for a range of a few hours to a day. Paving often leaves residents without driveway access for up to 4-7 days
- Parking in alternative locations will be required during the core out and paving processes. Thankfully, the City believes that many residents will have access to their homes from the adjacent alleys during the construction process. 1-way local traffic may be maintained for the bulk of construction.



Mail Delivery: How will I get my mail during construction?

Answer –

- Boomerang has coordinated with the Post Office for relocation of mailboxes to the alley between 6th & 7th Ave in clusters located on the east side of the alleyway during construction.
- Boomerang will reinstall mailboxes upon project completion.



Trash Pickup: What should I do with my trash?

- May 1st October 1st
 - Residents should place their trash at the back alley for the City to pick up per the normal schedule
 - Exceptions: residents along the east side of 7th Avenue from Ball Street to the southern project limits should put their trash out in front as normal (City unable to access alley)
 - If the City is unable to access this area for trash pickup, Boomerang will assist



What time will construction begin in the morning, and when will the contractor end work for the day?

Answer –

- Construction hours will be the same as normal working hours, with a few exceptions. During the paving process, working hours are often longer as the contractor begins early in the morning and ends later at night. With concrete paving, joints are often sawed in the late hours of the evening. The sawing process must be completed within a certain timeframe, as uncontrolled cracking of the pavement may occur.
- It is sometimes necessary for contractors to work on weekends and possibly holidays depending on the weather during construction.



Driveway Additions

I might like to repair or replace some of my driveway that is not within the ROW (from front of sidewalk to my house). Can the project contractor do this for me?

Answer –

 Possibly. Some contractors are willing to complete private work outside of the project limits and coordinate with property owners separately. However, some contractors are not willing to complete work beyond the City's project limits for various reasons. If you would like extra work completed, you may contact MSA following project bidding. If the project contractor is willing to complete extra work, MSA will forward your contact information on to the contractor. From there, the contractor will coordinate with property owners accordingly.



Sidewalk Replacement

I might like to repair or replace some of my sidewalk in front of my house. Can the project contractor do this for me?

Answer –

- Possibly. Some contractors are willing to complete private work outside of the project limits and coordinate with property owners separately. However, some contractors are not willing to complete work beyond the City's project limits for various reasons. If you would like extra work completed, you may contact MSA following project bidding. If the project contractor is willing to complete extra work, MSA will forward your contact information on to the contractor. From there, the contractor will coordinate with property owners accordingly.
- The City of Clarence implements a Sidewalk Assistance Program. Residents can fill out an application for a maximum cost share of \$500.
